## **TELUS Health Community Portal**

TERMS AND CONDITIONS (Last revised October 11, 2016, v.2)

TELUS Health Solutions GP (TELUS Health) is making the TELUS Health Community Portal available to all TELUS Health EMR and Pharmacy clients in order to improve our support services. By accessing the TELUS Health Community Portal, you agree, without limitation or qualification, to be bound by and to comply with these Terms and Conditions. Please read them carefully.

We may revise these Terms and Conditions from time to time. Your continued use of the TELUS Health Community Portal constitutes your acceptance of any such revisions. We encourage you to review this document regularly.

"You", "Your" and "Yours" refer to each TELUS Health EMR client who is granted a username and password to access the TELUS Health Community Portal.

"We", "Our" and "Us" refer to TELUS Health.

- 1. Description. The TELUS Health Community Portal enables you to submit online questions (Q&A section), to propose product suggestions (Ideas section) and to search for solutions in our knowledge base (Knowledge Base section). You can access our knowledge base, where we post FAQs, user guides, release notes and other useful information regarding TELUS Health EMR or Pharmacy solutions. For urgent request, please contact our service desk. TELUS Health will respond to your Submissions in accordance with its support obligations under a separate TELUS Health Agreement entered into between your business and TELUS Health for the use of the EMR or Pharmacy application.
- **2. Membership.** TELUS Health clients (physicians, other health professionals, pharmacists, and staff) are eligible to access the TELUS Health Community Portal. Registration is free.
- **3. Posting Content.** Please take care when entering information to ensure that you do not inadvertently reveal personally identifying details of individuals, including patients.
- 4. Forums and Content Submissions. The TELUS Health Community Portal may provide features that allow you to post messages and content, to interact with TELUS Health and other users and to upload files, documents or other materials (collectively. **Submissions**).
